

FTI-BAC RESOLUTION NO. 2020-03**BAC RESOLUTION DECLARING THE PROJECT "SUPPLY AND DELIVERY OF FTI ENTERPRISE RESOURCE PLANNING SYSTEM" AS "FAILED"**

WHEREAS, on 05 November 2020, the FTI Bids and Awards Committee (FTI-BAC) posted in the websites of the Food Terminal Incorporated (FTI) and the Philippine Government Electronic Procurement System's (PHILGEPS) alternative site, the Invitation to Apply for Eligibility and to Bid (IAETB) for the **SUPPLY AND DELIVERY OF FTI ENTERPRISE RESOURCE PLANNING SYSTEM**;

WHEREAS, the Pre-Bid Conference for the project was held on 18 November 2020, 10:00 AM, at the FTI Board Room of the FTI Administration Building and thru video conferencing;

WHEREAS, the Opening of Bids for the above mentioned project was held on 02 December 2020, 10:00 AM, at the FTI Board Room of the FTI Administration Building;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED;



d) To recommend the foregoing to the President of FOOD TERMINAL INCORPORATED for approval.






