

INVITATION TO BID

Food Terminal Incorporated (FTI) invites interested bidders to bid on the following projects:

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%, for the procurement of infrastructure) and sixty percent (60%, for the procurement of goods) for interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **FTI Administration Building** and inspect the Bidding Documents at the address given below from 8:00 am to 4:00 pm, Mondays to Thursdays, except Holidays.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents. *It may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The Food Terminal Incorporated will hold Pre-Bid Conferences on the dates specified above at the FTI Board Room, 2nd Floor, FTI Administration Building, FTI Avenue, Taguig City, which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below on or before the date and time stated in the Submission and Opening of Bids at the FTI Board Room, 2nd Floor, FTI Administration Building, FTI Avenue, Taguig City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18 of the Bid documents.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Food Terminal Incorporated reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
