- B. IMPLEMENTING AGENCY** : **FOOD TERMINAL, INC.**

- D. TECHNICAL SPECIFICATION** :

- b. Bidder must have a completed account to at least three (3) government agencies/ offices and alike.
- c. Bidder should be registered under by virtue of Philippine Laws.
- d. Direct sellers/ dealers only. Middle men are not allowed.
- e. Bidders must have similar projects with other government agencies/ GOCCs.


G. TIME FRAME :

Complete delivery of the vehicles within thirty (30) calendar days from the date of receipt of Notice to Proceed.

H. TERMS AND CONDITIONS :

1. Acquisition shall be through public bidding.
2. Warranty of units/parts and services shall be a minimum of three (3) years from date of acceptance.
3. Winning bidder shall be held liable for any defects found within the warranty period.
4. Defective unit within the warranty period shall grant immediate repair and replace the necessary part/s of the same and genuine type.
5. Winning Bidder shall meet at least the minimum required specifications.
6. Winning Bidder shall provide initial assistance on the basic knowledge of the vehicle's operation and its features.
7. Subject to usual terms and conditions under R.A. 9184 and its implementing rules.
